# INDIAN TEAM SELECTION TRIALS FOR



**TRIALS DATE: 24<sup>th</sup> SEPTEMBER 2025**

**VENUE: MALAKPUR SPORTS STADIUM, GREATER NOIDA, G.B. NAGAR  
UTTAR PRADESH**

## **RULES & REGULATIONS**

- 1. Name of Event:** Indian Team Selection Trials.
  - 2. Date:** 24<sup>th</sup> September 2025.
  - 3. Venue:** Malakpur Sports Stadium, Greater Noida, District G.B. Nagar (UP)
  - 4. Eligibility Criteria:** All participating athletes must fulfil the following conditions:
    - a) **Citizenship:** Must be an Indian citizen with valid government-issued identification.
    - b) **Passport Requirement:** Must possess a valid Indian passport with a minimum validity of 09 months from the date of selection.
    - c) **Age & Weight Categories:**  
**14 to 17 years ( Born 2009 – 2011 )**
      - **Boys: -65 kg, -83 kg.**
      - **Girls: -52 kg, -70 kg.**
    - d) **Prior Participation:**
      - A player will be eligible to participate in the selection trials only if they have participated in at least one national or international Kurash event within the past three years (from 2022).
    - e) **Health & Fitness:** Must be medically fit. A valid medical fitness certificate from a registered medical practitioner is mandatory.

## **5. Documentation & Equipment**

- a) **Mandatory Documents:**
  - Original passport (for age verification)
  - Two recent passport-size photos.
  - Original Certificate of past participation in a Kurash National or International event.

- b) **Kurash Uniform:** Participants must bring Green and Blue Kurash Yakhtak, as per international standards.
  - c) **NOC:** Submission of the Parent's Consent Form in the prescribed format of The Indian Kurash Association is mandatory at the time of reporting.

## 6. Selection Trials Format

- a) **General Format:**
    - Knock-Out format will be used in weight categories with six (6) or more participants.
    - Round Robin format will be used in categories with less than six (6) participants. (As per Point 8 of Point No. 32 (Order of Holding the Competitions) of the International Kurash Association Rules, if there are five or less players in the draw, a round-robin system will take place, (where every one fights one another)
  - b) **Match Duration:** Boys – 3 minutes, Girls – 3 minutes
  - c) **Officiating:** Conducted by certified referees and technical officials appointed by the Association.
  - d) **Rules:** Matches will be governed strictly as per the International Kurash Association rules.

## 7. Videography

- a) Videography of all matches is mandatory.
  - b) The Indian Kurash Association will record all matches for official review, transparency, and documentation purposes.
- 

## 8. Decision Review & Protests

- a) If a referee's decision is found incorrect during a match, it is the duty of the Jury Members to correct the decision immediately.

- b) If a coach disagrees with the decision, they must submit a formal protest within 15 seconds, along with a protest fee of ₹500.
  - c) If the protest is found to be valid after review, the protest fee will be refunded.

## **9. Final Selection**

- a) The first-place winner in each weight and age category will be selected to represent India at the Asian Youth Games 2025.
- 

## **10. International Participation & Costs:**

- a) The participation of players in the Asian Youth Games 2025, as well as the related financial expenses, will be subject to the approval of **MOYAS** and **IOA**.
- 

## **11. Additional Terms**

- a) The Indian Kurash Association reserves the right to amend or cancel the trials due to unforeseen circumstances.
  - b) All selected players (including reserves) must attend the national training camps organized prior to the Championship.
  - c) Submission of false documents, misrepresentation, or breach of discipline will result in immediate disqualification.
  - d) The Indian Kurash Association & Selection Committee shall not be held responsible for any injuries, accidents, or medical emergencies during the trials. All participants will compete at their own risk. In the case of minors, parents/guardians are fully responsible for the participation of their wards.
  - e) If any other situation arises that is not covered by this policy, it will be resolved by the majority decision of the selection committee.
