The Open Trials will be held from 18th to 20th September 2025 at SAI NCOE, Bhadbhada Road, near Sai Stadium, Gora Gaon, Bhopal, Madhya Pradesh 462044. Rules and Regulations

1. Organized By: Sports Authority Of India

The Open Selection Trials for Kurash Discipline will be conducted under the control and guidance of Sports Authority of India appointed Tournament Director and Technical Officials.

2. NAME & COMPETITION DATES:

- Open Selection Trials for Kurash Discipline
- **Date: 18th and 20th September 2025**
- **Venue: SAI CRC Bhopal, Bhadbhada Road, Gora Gaon, Bhopal, Madhya Pradesh 462044**

3. Minimum Eligible criteria for the selection trials.

- a. Citizenship: Must be an Indian citizen with valid government-issued identification.
- b. Age Limit: 17-35 (Born between 1 Jan 1990- 31Dec 2008)
- c. Passport Requirement: Must possess a valid Indian passport with a minimum validity of 6 months from the date of selection trials.
- d. Prior Performance: A player shall be eligible to participate in the selection trials only if they have secured at least one medal in Cadet, Junior or Senior age group at a National or International Kurash event in the past 3 years.
- e. Health & Fitness: Must be medically fit. A valid medical fitness certificate from a registered medical practitioner is mandatory.
- f. Athletes in the world ranking list of similar martial arts are not eligible to participate in the selection trials.
- g. Eligible Weight categories:

4. Documentation & Equipment

a. Mandatory Documents:

- Original passport (for age verification)
- Two recent passport-size photos.
- Merit Certificate of past participation in a Kurash National or International event in the last 3 years (From 2022).
- Self-declaration form attached in the Annexure-A.

- Kurash Uniform: Participants must bring Green and Blue Kurash Yakhtak, as per international standards.

5. Selection trials format

a. General Format:

- Elimination system (knock out), if five (5) or fewer players in one weight category Round Robin system will apply.

- Rules:** Matches will be governed strictly as per the International Kurash Association rules.

- c. **Officiating:** Conducted by certified referees and technical officials appointed by the Sports Authority of India.
- 6. Videography
 - a. Videography of all matches is mandatory.
 - b. The Sports Authority of India will record all matches for official review, transparency, and documentation purposes.
- 7. Participations/ Eligibility:
 - a. Athlete must possess a valid Indian passport with a minimum validity of 6 months from the date of selection.
 - b. All the players must fall in the respective weight Group, and as per the other rules and regulations mentioned.
 - c. Athletes can participate in one weight category only; however, one or more athletes from each State can participate in each weight category.
 - d. NO Merit/Participation Certificate will be issued to any athlete/official for this event/trials.
- 8. ENTRIES:
 - a. Final Entry by Name must be received on or Before 15th September 2025 through the registration link. NO Entry will be accepted after the deadline.
 - b. NO change or re-arrangement of players will be allowed after the entries are submitted until and unless injury/medical ground. A player who fails to qualify at any stage will be disqualified and no one else can be substituted in his/her place.
 - c. Xerox copy of the age proof of each competitor must be attached along with the Passport Copy.
 - d. Players must bring their latest two passport-size photographs.
- 9. WEIGH-IN:
 - a. A player must fit into his/her weight category and cannot play in a higher or lower weight category. Each competitor shall be allowed upon the scales only once during the official weigh-in.
 - b. Weigh-in will be conducted on the same day of the bouts.
- 10. DURATION:
 - a. Male: 4 Minute.
 - b. Female: 3 Minute.
- 11. Decision Review & Protests:
 - a. If the Decision of a referee on score or penalty is found incorrect during a match, it is the duty of the Jury Members to correct the decision immediately.

- b. If a coach disagrees with the score or penalty, they must submit a formal protest within 15 seconds, along with a protest fee of ₹500.
- c. If the protest is found to be valid after review, the protest fee will be refunded.

12. Final Selection

- a. **A National Coaching camp will be organised for the top 4 athletes in each weight category, and final selection trials will be held among the top 4 athletes before submitting the final entry to the International Kurash Federation.**
- b. The first-place winner shall be selected to represent India, and the second-place winner shall be selected as the reserve player for the respective category.
- c. Only 2 athletes in each weight category will attend the final phase of the National Coaching Camp.
- d. The duration of the camp will be determined on a later date by the duly constituted committee.

13. Additional Terms

- a. The Sports Authority of India reserves the right to amend or cancel the trials due to unforeseen circumstances.
- a. All top 4 selected players in each weight category will attend the NCC.
- b. Submission of false documents, misrepresentation, or breach of discipline will result in immediate disqualification.
- c. Sports Authority of India shall not be held responsible for any injuries, accidents, or medical emergencies during the trials. All participants will compete at their own risk. In the case of minors, parents/guardians are fully responsible for the participation of their wards. A declaration by parents /guardians should be produced during Documentation
- d. If any other situation arises that is not covered by this policy, it will be resolved by the majority decision of the selection committee.

1. Accommodation & Meals

- a. All participants are responsible for their own lodging and food arrangements.

2. Public Transport Access

- a. Nearest Bus Stand: Inter-state Bus Terminal (approx 11 km from venue)
- b. Nearest Railway Station:
 - i. Bhopal Junction Railway Station (approx. 12 km from venue)
 - ii. Rani Kamalapati Railway Station (approx. 11 km from venue)
- c. Nearest Airport: Raja Bhoj Airport, Bhopal (approx. 22 km from venue).

3. IMPORTANT PROTOCOL

- a. All athletes must be physically fit for the competitions.
- b. All participants Must follow the rules and regulations of the SAI Bhopal.
- c. Self-monitoring of health by all the participants and must report to the Technical Officials in case of any illness.
- d. Spitting in the field of play, arena is strictly prohibited.
