SELECTION POLICY FOR THE INDIAN KURASH TEAM FOR INTERNATIONAL EVENTS

The Indian Kurash Association (TIKA) has established a transparent selection process for International Events. This document outlines the criteria for selecting athletes based on their performance, ranking and trials.

STEPS OF SELECTION POLICY

1. RANKING SYSTEM

2. SELECTION OF PROBABLES

- a) After ranking calculations, the top 6 ranked players in each weight category will be selected as probable.
- b) If the 1st and 2nd position holders same weight categories from the last Senior National Championship are not in the ranking-based selection list, they will be included additionally.
- c) Wild Card Entry: The selection committee may grant a wild card entry to an additional player in the probable list of any weight category. This decision will be made based on a majority vote of the selection committee.

2.1. If International Event Weight Categories are Less than National Categories:

A fresh selection trial will be held to select 6 probable players, in which the following players will participate.

- a) Top 6 ranked athletes from the same weight category will be allowed to participate.
- b) Top 2 ranked athletes from one lower weight category will also be allowed to participate.
- c) If the 1st and 2nd position holders of same weight categories from the last Senior National Championship are not in the ranking-based selection list, they will be allowed to participate.

3. COACHING CAMP

- a) Coaching Camp will depend on Government Grants or TIKA Funds.

4. ELIGIBILITY FOR PARTICIPATE IN FINAL SELECTION TRIALS:

- a) Player who has been selected as a probable.
- b) The player must have a passport of the Republic of India with a validity of 8 months.
- c) Minimum age required to Participate in Selection Trials according to IKA Rules.
- d) Medical clearance is mandatory.
- e) All probable players must pass a fitness test before the final selection. Any player failing the fitness test will be replaced by the next ranked player from the probable list.

5. FINAL SELECTION TRIALS:

- a) The final selection will be based on the results of the match.
- b) The matches in final selection trials will be conducted on a round-robin basis.
- c) If only 1 player is to be sent: The 1st position holder in the selection trials will be selected.

- d) If 2 players are to be sent: The 1st and 2nd position holders in the selection trials will be selected automatically.

5.1. Special Case for Match Decisions & Absentees

If the Selection Committee feels that a match decision was wrong, they may:

- a) Correct the decision immediately.
- b) Re-conduct the selection trial for that weight category (only once) to ensure fairness.

These decisions will be made based on a majority vote of the Selection Committee.

6. CODE OF CONDUCT & DISCIPLINE

- a) Any disciplinary action, doping violations, or misconduct will lead to disqualification.
- b) Selected players must adhere to The Indian Kurash Association's guidelines.

7. FINAL SELECTION APPROVAL

- a) The Selection Committee of the Indian Kurash Association will review the final trial results.
- b) The decision of the selection committee will be final and binding.

8. ANY OTHER

If any such situation arises that is not covered by this policy, it will be resolved by the majority decision of the Selection Committee.

This structured and transparent system ensures that only the best and most deserving Players Represent India in International Kurash Championships.
